- Step 2b: If yes, there are two conditions:
  (a) we are speaking about a list of names and countries of residence only (i.e., no titles, no photos, no positions, no email addresses, no links, no CV's),

(b) we ask permission twice: once to publish the member's name *before* publication (worded as: yes, unless you disagree), once when the member's name is published and whether it has to be removed.

The Executive unanimously carried the recommendation to approach members with an opt out for their names to be listed, without position and email. They will have two opportunities to refuse listing.

In addition, the Executive will seek for (1) the member list to be linked to the ICHTH Wikipedia pages and (2) the individual Wikipedia pages of members who are not currently linked to the ICHTH Wikipedia pages to be linked.
